Control Union Certifications has conducted a verification assessment with ISF, and the objective of the assessment was to perform a third-party review of the NDPE IRF verification information by ISF based on the requirements of the NDPE IRF Verification Protocol. In 2024, the company sourced its raw material only from 29 palm oil mills. As reported in its IRF Profile, ISF has sourced 555,444.99 MT of Crude Palm Oil (CPO) and Crude Palm Kernel Oil (PKO) combined.
